CONSENT FOR USE OF LIVE IMAGES OF A CHILD OR YOUNG PERSON UP TO 16 OR FOR A PERSON AGED OVER 16 WHO CANNOT GIVE CONSENT FOR THEMSELVES

VIA THE INTERNET, INCLUDING WEB BROADCASTING, PERISCOPE AND FACEBOOK LIVE

Parish of St. Mary and St. Benedict Church, Coventry

The Parish streams images of Mass and other liturgies via the internet so that:

- Housebound parishioners can access weekly or even daily Mass in a way that works against isolation.
- Relatives who cannot attend a baptism/wedding/funeral can access it in a way that brings great comfort.
- Those who for any reason cannot/do not attend church can access the Church's worship from anywhere in the world, this is therefore a tool for evangelisation.

To be completed by the person whose image is to be streamed (especially if they are performing a role e.g. altar server) if they understand what they are agreeing to.

As a person who will be visible on and recognisable from the streamed images which are transmitted via the internet, because of the role I have as a Minister, volunteer or member of staff, I understand that:-

- The Parish needs my consent, which I can withdraw at any time without explanation by calling in, contacting the parish office by phone, by email or by letter.
- The planned use of these images is to be streamed live on the internet where they may be viewed by [anyone who wishes to do so] or [those who have registered with the parish only].
- The images may also be recorded by the parish and used for [add purpose]. If recorded, the images will be kept securely for a maximum of [add period of time] (unless the terms of use are renegotiated with me).
- Some people who view the images on the internet may be able to record and keep them and the Parish has no control over how such images may be used.

I give my express consent to my image being live streamed in the course of the activities detailed above.

I understand the ways in which my image may be accessed via the internet as set out above and (if they are recorded by the parish) the period of time, and manner in which they will be stored and used.

I know that it is my right to withdraw my consent at any time, without explanation. I understand that if I withdraw consent it is unlikely that I will be able to continue in my role and that if I withdraw my consent that will not affect the lawfulness of any processing carried out by the Parish before I withdraw my consent
